Care Receivers Anna and Don say thanks!

Anna and Don of Bloomington have been receiving services from Faith in Action since June of 2006. Anna heard about us from a friend. "A nurse from Faith in Action came out to interview us, and you've been stuck with us ever since."

Faith in Action volunteers provide grocery shopping assistance every two weeks for the couple, as well as transportation to their medical appointments. "Since I had a

mastectomy this summer, I've had more appointments than you can shake a stick at...the surgeon, the cancer doctor, blood tests....I'm hoping that's pretty well out of the way."

Anna states that FIA has been a blessing to her. "I am totally blind, and my husband is partially blind."

Don interjects, "I can see just enough to get into trouble, and she keeps me out of it."

Anna continues, "He has two children who live out of state, and we rely on Faith in Action for our independence."

Anna and Don married in 1993 after they met through a group of blind friends who would go out to eat in

Chicago. They moved here in 1997.

Don has a collection of timepieces that includes a grand-father clock and ten cuckoo clocks which they enjoy hearing mark the time. The couple also enjoys listening to Don's collection of 3,000 classical records. Mary commented, "We also collect stuffed animals....I don't know how that got started exactly, but how could anyone say no to them when they just jump into your arms?"

Through the support of the volunteers of Faith in Action for grocery shopping and transportation to medical appointments, Don and Anna are able to remain in their own apartment, surrounded by the collections that they enjoy so much.

Q & A with Director Linda Bollivar

Casseroles:

I heard Faith in Action was giving away casseroles. How do I get one?

Linda says: Thanks to the generosity of Red Oak Comfort Foods we have casseroles to give away each week to our care receivers. The casseroles are



frozen in a foil pan. If you receive one, store it in your freezer until you are ready to use it. If

the casserole makes more than you can eat right away, freeze the leftovers in individual portions. If you are a care receiver and have not had a casserole yet, please call our office and request one. Volunteers who know of a care receiver who might enjoy a casserole should contact the office. There is a handy check out procedure so we know where they have gone.

Transportation Timing:

Why do I have to request rides in 3 to 4 business days ahead?

Linda says: Our office coordinates rides for more than 350 care receivers, and matches them up with one of 250 volunteers. Care receivers may have



limitations on the size of vehicle they can ride in, whether they prefer a male or female driver, etc. The volunteers have limits on the days

they are available, what type of transportation they are available for, how far they drive, etc. We may need to make a dozen or more phone calls to fill your ride. So, we ask that you call

our office as soon as you make an appointment, and at least 3 to 4 business days before the ride is needed. We are open Monday – Thursday from 9:00 a.m. to 4:00 p.m. If we are closed, you may leave a message on our answering machine. We are sorry that we cannot cover last minute appointments.

Showing Appreciation:

I am so happy with the volunteers you sent. Can I pay them to thank them?

Linda says: We are very happy to hear that you are pleased with the volunteers from Faith in Action. However, our volunteers do not expect and cannot accept any payment! If you feel moved to make a donation, you can send it to Faith in Action, 410 N. Prairie, Bloomington, IL 61701. Donations help with our expenses such as phone, mailings, computers, etc. At the holidays, if you want to give your favorite volunteer a card, or something with a value of less than \$10, that is fine, but we never want you to feel like you owe anything to the volunteers or to Faith in Action.

Timesheets:

I love volunteering with Faith in Action, but I really don't like keeping track of my hours and turning them in. Why do you need that information anyway?

Linda says: Bless you for your service to others through Faith in Action! Although it might seem like a lot of work, recording your hours and turning

them in to the office helps us in many ways. When we want to measure the

health of our organization, we look at the numbers of volunteers and care receivers, as well as the number of hours



of service to see if we are growing, shrinking, or staying the same. Also, when we give presentations to potential donors, the number of volunteer hours is one measure that they use to see how much impact we are having on the community.

You can call in your hours, email them, drop off a form, or mail it in. But please, whatever you do, let us know how many hours you are volunteering on behalf of Faith in Action. And, if you are over 55, you can also turn your hours in to the YWCA's RSVP (Retired and Senior Volunteer Program).

From Pat's Pantry Mock Apple Pie

Ingredients

6 cups zucchini (extra large because they are firmer)

- 1 1/4 cups sugar
- 1 1/2 Tbsp. flour
- 1 1/2 tsp. cream of tartar
- 1 1/2 tsp. Cinnamon

 Dash of salt

Dash of nutmeg

Dough for 9 inch double pie crust.

 Pare zucchini, wash and slice lengthwise.
 Remove seeds. Slice like apple slices.

- Add a little water and bring to a boil in large saucepan, then simmer for 15 minutes until tender. Cool and drain well
- Add rest of ingredients and place into an unbaked 9 inch pie crust.
- Cover with top pie crust and flute to seal edges. Cut slits into top of crust (for steam to escape).
- 5. Bake at 350 degrees for 45 to 60 minutes.
