
## **FAITH IN ACTION SERVICE GUIDELINES**

- 1. Care Receivers need to call the office at least 7 days in advance. We can accept ride requests months in advance too.
- 2. Wheelchairs cannot be transported. Walkers and canes are acceptable. A Care Receiver must be able to get in and out of a vehicle independently.
- 3. Medical transports are acceptable. Sorry, FIA Volunteers are not able to transport to the bank or hair appointments at this time.

Faith in Action Volunteers provided 6,677 medical rides in 2021.

Faith in Action Volunteers provided 1,153 rides to grocery stores and food pantries. In 2021 Volunteers provided services to 400 Care Receivers.



## Beware of Social Security Phone Scams



UNKNOWN CALLER

Telephone scammers are pretending to be government employees. They may threaten you and may demand immediate payment to avoid arrest or other legal action. Do not be fooled!

#### If you receive a suspicious call:

- 1. HANG UP!
- 2. DO NOT GIVE THEM MONEY OR PERSONAL INFORMATION!
- 3. REPORT THE SCAM AT OIG.SSA.GOV

## What to look out for



The caller says there is a **problem** with your Social Security number or account.



Any call asking you to pay a fine or debt with retail gift cards, cash, wire transfers, or pre-paid debit cards.



Scammers **pretend** they're from Social Security or another government agency. Caller ID or documents sent by email may look official but **they are not**.



Callers threaten you with arrest or other legal action.

### Be Alert

Social Security may call you in some situations but will **never**:

- » Threaten you
- » Suspend your Social Security Number
- » Demand immediate payment from you
- » Require payment by cash, gift card, pre-paid debit card, or wire transfer





### Be Active

Protect yourself and your friends and family!

- » If you receive a questionable call, just hang up and report the call at oig.ssa.gov

- » Share this information with others

#### PEARLS: Program to Encourage Active Rewarding Lives

The PEARLS program teaches you skills to manage unpleasant feelings and improve your quality of life.

#### Who can receive services?

- Adults age 60+
- Residents of McLean County
- Minimum of 1 session per month
- Meet in person's home or in a confidential office setting

## Counseling may help if you are having difficulty with:

- Decrease in physical or pleasant activities
- Social isolation
- Grief from the loss of a loved one
- Coping with mental illness or chronic health conditions
- Aging and other geriatric issues
