
REMINDERS

McLean County Veterans Assistance Commission

The McLean Veterans Assistance Commission (VAC) assists indigent veterans and their families with limited temporary emergency financial aid. They also have information for health benefits and burial information. With the PACT Act passing there are more benefits available to Veterans who were affected by burn pits, Agent Orange, and many other toxins. This office also maintains a food bank for Veterans and Veterans' families. Recently the Caregiver benefits too have been expanded to Veterans with 70% disability. 
